

## MLA Documentation for Works Cited Page Practice Sheet

*-PLEASE NOTE: All citations should be double-spaced-*

### ► An Article from an Online Database (ex: SIRS, or EBSCO articles)

Last Name of Author, First Name. "Title of Article." Name of News/Mag—Underlined

Month Day, Year of Publication: Page Numbers. Name of Database—Underlined. Web. Day Month Year

source was accessed.

**Example:** Smith, Joan. "The Traumatizing Effects of Psoriasis." The Journal of Skin Lesions Feb. 21, 2006: 22-23. SIRS  
Researcher. Web. 1 March 2004.

### ► A Printed Book with One Author

Last Name Author, First Name. Title of Book—Underlined. City of Publication:

Publishing Company, Year of Publication. Print.

**Example:** Jones, John. Dermatitis and You. Itchigoomee: Knopf Inc., 2007. Print.

---

### ► An Article in a Printed Journal

Last Name Author, First Name. "Title of Article." Title of Periodical—Underlined.

Volume Number or Issue Number (Year of Publication): Page Numbers of Article. Print.

**Example:** Rodriguez, Juan. "Ringworm Gets Under Your Skin." Skin Diseases Quarterly. 44 (2007): 1-22. Print.

### ► An Article in a Daily Printed Newspaper

Last Name Author, First Name. "Title of Article." Title of Newspaper—Underlined.

Date of Publication, Section followed by Page Number. Print.

**Example:** Klumittonitz, Olga. "Scabies: Frightful Mites that Bite at Night." Pawtucket Times. 19 Sept. 1999, A19-A22.  
Print.

## ► An Article in an Online Magazine

# MLA

Last Name Author, First Name. "Title of Article." Title of Journal—Underlined.

Volume or Issue (Year of Publication): Page number(s), if given. Web. Day Month Year You Accessed the Source.

**Example:** Kloomp, Jonas. "Skin Rashes that Unite us: Folliculitis." The American Barber. 10 (2002): 3. Web. 4 Jan 2003.

---

## ► A Website

Last name, First name of site's author. Title of Website- Underlined. Name of organizations sponsoring the website, Day Month Year website was published. Web. Day Month Year website was accessed.

**Example:** Popopolous, Konstantin. These Shingles Aren't On Your Roof. The American Shingles Association, 14 Aug. 2006. Web. 10 August 2009.

## ► An eBook

Last Name Author, First Name. Title of eBook—Underlined. City of Publication of print version, Year of Publication of print version. *eBrary*. Web. Day Month Year you accessed the eBook.

**Example:** Cheex, Rosie. Rosacea is NOT a Flower. Portland, 2004. *eBrary*. Web. 3 Aug. 2009.

---

### Important Notes:

- Dates are written with the day first, then the month, followed by the year.  
For example: 27 Feb 2008
- If there is more than one author, start with the author that is first listed in the text. Then, put the other author's name(s), using his/her *first name first*. For example: Smith, John and Judy Blue.
- For books with only an editor, cite the editor as you would cite an author, except put a comma after the editor's last name followed by "Ed." to indicate the person is the editor. For example: Brown, Jack. Ed.
- Consult the 7<sup>th</sup> edition of A Writer's Reference by Diana Hacker or the MLA Handbook for further referencing.
- Second lines, and all consecutive lines of text, should be indented ½ inch from the initial line of text.
